## ✤ <u>GUIDELINES FOR NOMINATION OF SUPERVISORS</u>

- 1. Main Supervisor will have to be UNITEN academic staff.
- 2. For Structure A, one (1) Co-Supervisor from UNITEN must be appointed. If special expertise is required, the co-supervisors can be appointed from other university to provide insights and guidance in those areas of specialization.
- 3. For Structure A, on a case-to-case basis, a Field Supervisor from industry may be appointed to enhance and facilitate project supervision.
- 4. A student may request to be supervised under his/her preferred area of research provided the expertise is available.
- 5. The Main Supervisor, Co-Supervisors and Field Supervisor should not be currently registered as a postgraduate student at UNITEN or at any other universities.
- 6. Co-Supervisors are not encouraged for Structure C.
- 7. The Dean of College of Graduate Studies approves the appointment of Supervisors for theses, dissertations and projects based on the following qualification requirements:
